### PROGRAM PAYMENT KNOWLEDGE

The 2024 Futsoccer International program fees are 2650 Euros for the ground expenses per individual player. (This amount is subject to change due to the Euro-dollar accuracy). Before proceeding with any payment on this program, please read and be aware of the program description, trip schedule, calendar, trip full costs, and refund policies. The International Airfare cost is "Not included" Each family is responsible for purchasing the international flight tickets.

All participants must pay a \$300 non-refundable deposit to secure a spot in the program. Futsoccer provides a payment plan for players and family members, the balances must be fully paid by May 5th, 2024.

### **REFUND POLICY**

- A payment terms agreement is a legal contract between a buyer and seller that outlines how payments will be made.
- It can also outline what happens if the customer does not pay on time and what interest rates and late fees may apply. This type of agreement is beneficial for both parties.
- Payment term is documentation that details how and when your customers pay for your goods or services. Terms of payment set your business's expectations for payment, including when clients pay and what penalties they may receive for missed payments.
- The program Registration fee initial deposit of \$300 dollars is Non-refundable. The balance must be fully paid in Euros currency money from Europe by May 5<sup>th</sup>, 2024.
- The deadline for the trip ground expenses refunds (not including the initial deposit of \$300) is applicable till April 15<sup>th</sup> or 75 days before the trip day June 29<sup>th</sup>, 2024.
- After this date all funds paid, "Can Not be refunded" No expectations. Since the initial commitments between Futsoccer and all the event organizers, hotels, tournament expenses, transportation, meals, and coaches' compensation must be completed.
